# Health Equity: Improving birth outcomes for mom and baby across the Carolinas

Every baby deserves the healthiest possible start in life. However, significant racial and ethnic disparities exist among birth outcomes for pregnant women and infants. For example, non-Hispanic black infants have significantly higher rates of low birthweight, preterm birth and infant mortality compared to non-Hispanic white and Hispanic infants. During this session, the presenters will discuss health equity from a national, state, and systems perspective and identify opportunities for addressing health inequalities that impact birth outcomes. Participants will leave with a more thorough understanding of how health inequalities impact health outcomes and actions they can take to improve the care provided for women and babies to ensure they thrive before, during, and after birth.

# NICU Care: What is new? How is care changing? How do we measure value?

## **Keynote Speakers**

### **Elizabeth Bradley**

Elizabeth Bradley, Esquire, is an Associate General Counsel at Palmetto Health. She received her undergraduate and law degrees from the University of South Carolina. After graduation, Ms. Bradley was a law clerk for the Honorable G. Ross Anderson, Jr., Federal Judge in Anderson, SC, and then practiced in the administrative law division at the McNair Law Firm, focusing mainly on health care. She subsequently worked as General Counsel for the Insurance Reserve Fund and acting General Counsel for both Procurement and IT at the South Carolina Budget and Control Board prior to joining Palmetto Health. She is a Past President of the Richland County Bar and past Board Member for the University of South Carolina Board of Visitors.

### Berry Campbell, MD

Dr. Berry Campbell completed his Obstetrics and Gynecology Residency and Maternal-Fetal Medicine Fellowship at the Medical University of South Carolina in Charleston, SC. After completing his MFM fellowship, Dr. Campbell accepted a position at the University of Kentucky. He served as Director of Genetics & Prenatal Diagnosis and as Director of Obstetrics Outreach Clinical Services in the Department of Obstetrics and Gynecology. Dr. Campbell ultimately served as the John Greene Professor and Chairman and Director of the Maternal-Fetal Medicine Division, Department of Obstetrics and Gynecology at the University of Kentucky. Dr. Campbell left academia in 2002 for the private practice of high risk obstetrics. He served as Director of Kentucky One High Risk Obstetrics for a couple of years. He joined the faculty of the Department of Obstetrics and Gynecology, University of South Carolina School of Medicine, Division of Maternal-Fetal Medicine as Director in December, 2015.

### **Constance Guille, MD**

Dr. Guille is an Associate Professor in the Department of Psychiatry and Behavioral Sciences and Obstetrics and Gynecology at the Medical University of South Carolina (MUSC). She completed her psychiatry training and subspecialty training in perinatal psychiatry at Yale University. She is the Director of the MUSC Reproductive Psychiatry Fellowship and Women's Reproductive Behavioral Health Programs. This program provides mental health and substance use treatment to pregnant women both in-person and via telemedicine in obstetric practices in SC. She is the recipient of two career development awards including funding from the National Institute on Drug Abuse to evaluate pharmacological and behavioral interventions for pregnant women with perinatal opioid use.

### Clifton J. Kenon Jr., DNP, MSN, RN

Dr. Clifton J. Kenon Jr. is a native of North Carolina and has spent his entire nursing career in perinatal nursing. Starting his career at the Duke Birthing Center, he has worked at both academic and rural hospitals in obstetrics and lactation. Dr. Kenon is currently a Senior Research Advisor in the Office of Population and Reproductive Health at the United States Agency for International Development. Dr. Kenon previously worked as the director of maternal child health for the Indian Health Services. A lactation consultant and nurse educator, he has lectured worldwide on perinatal health, family planning, lactation, and health disparities. He has published in a variety of journals, and his honors include national awards from The Surgeon General, the White House, the National Public Service Award, and the Reyes award from the Indian Health Service. Dr. Kenon, when not working, enjoys running his lactation practice and showing his dogs.

### Shelly Tanner, RN, BHS, MSHL, CPHRM

Shelly Tanner obtained her associates degree in nursing from Charlotte Mecklenburg School of Nursing, her bachelor's in Health Sciences from MUSC and her Master's in Health Law from Nova Southeastern University. She has also completed several risk management educational programs to include earning her certificate in Health Care Risk Management from the University of South Florida. Shelly works closely with the South Carolina Hospital Association (SCHA) on state wide projects to include High Reliability and Just Culture. She is currently the director of Patient Safety and Risk Management for Palmetto Health, leading the risk program for a 1138 bed system and 40 ambulatory practice setting.

### Heather Waleski, BSN, RN, SANE-A

Heather Waleski is currently the Forensic Program Coordinator at Carolinas HealthCare System Union, which covers four hospitals for Union, Anson and Stanly Counties. Heather has been an Emergency Department Nurse for 15 years and a Sexual Assault Nurse Examiner for 10 years. She has conducted Adult and Adolescent SANE trainings in the Charlotte area for 7 years. Heather is a SANE-A, has completed the SANE pediatric training, and is President-Elect for the International Association of Forensic Nurses—North Carolina chapter for 2018. She is also a member of the Charlotte Metropolitan Human Trafficking Task Force and Rapid Response Team covering Mecklenburg and Union County.
